Data Protection Information for Event Participants

Protecting your personal data is important to us. With this information, we fulfil our obligation under Art. 13 of the General Data Protection Regulation (GDPR). These data protection notices are directed at individuals who register for or attend our events. The purpose is to inform you transparently and clearly about how your data is handled in the context of registration, participation and documentation of events.

3. Purposes of Processing and Legal Basis

We process your personal data for the purpose of organising, conducting and following up the event for which you registered or in which you participate. This includes, in particular, managing registrations, communicating with you in connection with the event, creating participant lists as well as organisational planning and on-site execution. The legal basis for this processing is Art. 6 para. 1 lit. b GDPR (performance of a contract or pre-contractual measures).

In addition, photo and video recordings may be taken during the event in which you may be identifiable. These recordings serve the documentation and public relations work of the organiser, for example through publication on the website, in social networks or print media. The legal basis for this is our legitimate interest pursuant to Art. 6 para. 1 lit. f GDPR in conjunction with § 23 KunstUrhG.

If you do not wish for recordings of you to be published, you may inform the organiser at the beginning of the event.

4. Categories of Personal Data and Data Subjects In the context of registration and participation in events, we process personal data of participating individuals. This

- · Basic data such as name, first name, title if applicable, company or organisation
- · Contact details such as e-mail address, telephone

includes in particular:

number or postal address

- · Event-related data such as registration date, confirmation of participation, preferences (e.g. dietary requirements) as well as organisational details for event execution
- · Communication data arising in the context of correspondence or contact
- Photo and video recordings produced during the event in which you may be identifiable

Only persons who register for an event, participate in it or are involved in its organisation are affected.

5. Recipients of Personal Data

Your personal data will generally not be transferred to third parties. A transfer only takes place insofar as it is necessary for the execution of the event or a legal obligation requires it. This may include service providers who support us in organising and executing the event, such as event agencies, IT or communication service providers, as well as photographers. These service providers are contractually bound to confidentiality and compliance with applicable data protection regulations.

6. Duration of Storage

We store your personal data only as long as necessary for the organisation, execution and follow-up of the event or as long as legal retention periods apply. After completion of the event and expiry of any applicable periods, your data will be deleted unless further consent exists or other legal reasons require longer storage. Photo and video recordings are retained as long as they are used for documentation and public relations purposes and unless you object.

7. Your Rights as a Data Subject

You have the following rights in connection with the processing of your personal data:

- · Access to your stored data (Art. 15 GDPR): You may request information at any time about which data we have stored about you and for which purposes these data are being processed.
- Rectification of inaccurate or incomplete data (Art. 16 GDPR): If your data are incorrect or incomplete, you may request that they be corrected without delay.
- Erasure of your data (Art. 17 GDPR): You have the right to request the deletion of your data, provided that no statutory retention obligations or other legitimate reasons prevent their deletion.
- Restriction of the processing of your data (Art. 18 GDPR): Under certain conditions, you may request that your data be processed only in a restricted manner, for example if you contest the accuracy of the data.
- Objection to the processing (Art. 21 GDPR): You may object to the processing of your data if reasons arise

from your particular situation that speak against the processing.

• <u>Data portability</u>, where applicable (Art. 20 GDPR): You have the right to receive the personal data concerning you in a structured, commonly used and machine-readable format and to transmit those data to another controller.

8. Withdrawal of Consent

If processing is based on your consent, you may withdraw it at any time with effect for the future. The lawfulness of processing performed before withdrawal remains unaffected.

9. Right to Lodge a Complaint with a Supervisory Authority

You have the right to lodge a complaint with a data protection supervisory authority if you believe that the processing of your personal data violates the GDPR.

10. Provision of Data and Necessity

The provision of your personal data is necessary for the organisation and implementation of the event. Without providing the necessary data, it is not possible to register for or participate in the event. If certain information is voluntary, this will be indicated accordingly during the data collection process.

11. Transfer to Third Countries

Personal data will not be transferred to a third country outside the European Union or the European Economic Area.

12. Automated Decision-Making

No automated decision-making or profiling takes place.
